

## **NOTIFICATION**

## Regarding the Dept. of Higher Education Communication No.17-Pr.Secy-HED/2020, dt.30.07.2020

In pursuance of the Communication from the Higher Education Department (vide **No.17-Pr.Secy-HED/2020**, **Dated 30.07.2020**) and the subsequent communication from the West Bengal State University (vide No.WBSU/Reg/Notice/COVD/55/2020-21, dt.31.07.2020), the following are notified for information of all concerned:

- (a) The College including its Hostels will remain closed till **31**<sup>st</sup> **August 2020** as in the above communications.
- (b) Administrative segments of different facets of the College, including that for examinations, will remain operative, as at present, under strict compliance of the COVID-19 protocols and guidelines as cited in earlier communications. All the Officers and Support staffs of the College are requested to discharge their respective administrative, official and allied obligations and duties, as applicable, however, under strict observance of the protocols and guidelines framed towards prevention of COVID-19 menace.
- (c) Office proceedings of the College too will remain operative, to the extent it is operating at present adopting the strict precautionary measures to fight against the hazards of COVID-19 virus.
- (d) Online enrolment of the now-in Semester-II & Semester-IV students (UG & PG), to the next-higher Semester, will remain open as per the guidelines and stipulations promulgated in the preceding Notification No.75, dt.27.07.2020.
- (e) Online classes for the newly-enrolled Semester-III & Semester-V (UG & PG, as applicable) Students will be started from 05/08/2020 onwards following the strategy and guidelines elaborated in the Notification No.75, dt.27.07.2020.
- (f) The procedure of ensuing online admission to Semester-I (UG) of the College will remain operative as per the guidelines contained in the Department of Higher Education, Govt. of West Bengal, Notification (vide No.434-Edn(CS)/10M-95/14, dt.16.07.2020) and the WBSU Notification (vide No.WBSU/Reg/UG/Notification/54/2020-21, dt.31.07.2020). In terms of this online admission, any notification/advisory/order that may be circulated in the coming days by the Department of Higher Education, Govt. of WB, would be adopted together with those from the West Bengal State University (WBSU) relating the same matter. Further, regarding this issue of online admission, all concerned are also urged to consult exhaustively all the forthcoming notifications of the Taki Government College and those from the WBSU, which would be circulated time to time in the future course.

Additionally, it is to be noted that as and when Directives/Orders/Advisories from the Govt. of West Bengal (GoWB) and/or the Dept. of Higher Education, GoWB or WBSU, vis-à-vis monitoring the activities relating academics/admissions/examinations & allied matters under the current COVID-19 situation comes, further notifications will be promulgated from the College to address concurrent issues of the institution.

All concerned are hereby requested to take note of this promulgation.
