NOTIFICATION

**[Regarding Enrolment of Semester-II & Semester-IV Students To the Next Higher Semester-III & Semester-V Respectively for UG and PG Students]**

It is notified for all concerned, specially the students in Semester-II & Semester-IV strata now that they are to enroll themselves for the next higher Semester-III & Semester-V respectively (both for UG and PG) as applicable. In terms of the mentioned enrollment to the next higher Semester, the following assertions are to be heeded by all concerned:

- (a) The Students of now Undergraduate Semester-II and Semester-IV are advised to register their names for the next higher Semester-III & Semester-V through online mode with appropriate subject-entry as applicable. Similarly, Students of Postgraduate Semester-II are urged to enroll for the next higher Semester-III.
- (b) Enrolment through online mode could be achieved by going to the College Cloud-Portal through College website ([www.tgc.ac.in](http://www.tgc.ac.in)) and by clicking on the **Student/College Login** button/menu. Students need to login to the Cloud-Portal by putting valid login-credentials in the Student-Login slot. Once in the Cloud-portal, Students would be able to complete the enrolment process, however without making any payment whatsoever. Once again: it is to be noted that NO PAYMENT of any fees needed at this point of time. **This narrated procedure for enrolment is to be followed by the Students belonging to both Undergraduate and Postgraduate streams.**
- (c) The Cloud-portal would be made available to the Students for enrolment from the date 29/07/2020 starting at 12:00 Noon and onwards.
- (d) All the Students are urged to complete enrolling them to the next-higher-semester preferably before 5<sup>th</sup> August 2020. This is because the College Authority is taking active initiative to **start Online Classes for Semester-III & Semester-V (UG) and for Semester-III (PG)** from 05/08/2020 onwards. The departmental Head designates and other colleagues are hereto thus urged for taking appropriate measures so as to start online classes for the above mentioned Semesters on and from 05/08/2020 as per pre-defined schedules.
- (e) In terms of selecting subject(s)/Paper(s) etcetera in the next-higher-semester, concurring the University (WBSU) Registration & Curriculum, Students may consult their respective departmental Teachers and apropos the Faculty members are requested to offer such counseling benevolently.
- (f) Consequent upon the instructions as in (b) above, it is to be noted that enrolment-option will remain active even after 05/08/2020. However, as urged above, by enrolling before 05/08/2020 a student will be able to extract benefit maximum of ensuing online classes/tutorials/lectures.

All the concerned stakeholders of Taki Government College are hereby requested to take note of this promulgation and are also urged to do the needful on their respective parts following the narratives as contained in the clauses (a) – (f) above.
