Sub: Communication to combat spread of Novel Corona Virus (COVID -19).

Sir / Madam,


In pursuance to order and guidelines issued by Ministry of Home Affairs vide no 40-3/2020-DM-1(A) dated 24-03-2020 and dated 15-04-2020 read with subsequent orders issued from time to time and in view of the prevailing situation on the spread of Novel Corona virus (COVID – 19) and as in pursuance of discussion held with Vice Chancellors of all Universities, it has been decided by the competent authority in the Government of West Bengal that all Government, Government-aided, private educational institutions, Training Institutes will remain closed up to 30th June, 2020 in public interest.

2. Administrative departments of colleges/universities like the office of Vice Chancellor, Registrar, Finance/Examination department, Head of the institute including emergency services e.g. electricity, cleanliness, water supply, security etc may remain open under strict COVID-19 protocol and extant guidelines issued, as per local need to be decided by the head of respective institute. Different Universities within the umbrella of Higher Education Department, will intimate about the planning / arrangements made regarding the conduct of terminal / intermediate semesters' exam, to the Higher Education Department, considering prevailing situation.

3. Hostels will also remain closed till ~~May~~ 30th June 2020 though, adequate arrangements as per the medical protocol will be made by the respective institute for the foreign students who are not able to leave the campus due to distance or otherwise. No visitor should be allowed during the period to visit the hostel, without prior approval of the Head of the Institute.

This is for your kind information and necessary action, with a request that all colleges under your control may also be advised accordingly.

In pursuance of the text of above communication, the following are notified for information of all concerned:

- The College including its Hostels will remain closed till 30th June 2020 as in the above communication.
- Administrative segments of different facets of the College are to be operative, however, under strict compliance of the COVID-19 protocols and guidelines, as cited in the above communication. All the Officers and Support staffs of the College are requested to discharge their respective administrative, official and allied obligations and duties, as applicable, however, under strict observance of the protocols and guidelines framed towards prevention of COVID-19 menace.
- Office proceedings of the College would be made operative to the extent feasible, in the present COVID-19 situation, at the conclusion of Summer Vacation on 10/06/2020 (notified earlier No.65, Dt.28.04.2020). Additionally to be noted, that, as and when Directives/Orders/Advisories from the Govt. of West Bengal (GoWB) and/or the Dept. of Higher Education, GoWB or WBSU, vis-à-vis the ongoing COVID-19 situation, comes, further notifications will be promulgated from the College to address various institutional matters.
